Customer information on the subject of REACH

Directive (EC) No. 1907/2006 (REACH Directive) and information obligation

Dear Sir or Madam,

the products supplied by SEW-EURODRIVE are referred to as "products" pursuant to REACH terminology. In this context, SEW-EURODRIVE is a "downstream user".

If SEW-EURODRIVE learns that one of its products contains a substance of very high concern (SVHC) on the latest ECHA candidate list that occurs in a concentration that is greater than 0.1% by mass (w/w), then we will disclose it as per the information obligation pursuant to Article 33 of the REACH Directive.

We purchase the lubricants and oils in SEW-EURODRIVE products from reputable manufacturers, under whose responsibility the substances contained therein were registered with the ECHA in accordance with the REACH Directive.

The aforementioned circumstances likewise apply to auxiliary materials and operating supplies (e.g. lubricants and oils) that are supplied under the SEW-EURODRIVE brand or traded by SEW-EURODRIVE. A safety data sheet pursuant to Article 31 of the REACH ordinance will be provided.

SEW-EURODRIVE is currently engaged in a dialog with its suppliers regarding their REACH obligations and regarding the safe use and risk management measures related to the supplied substances, preparations and products.
